Important studies are being discussed at the South Bruce Community Liaison Committee meetings this summer. We are beginning to get a clearer picture for how South Bruce may look in the future – with or without the DGR project.

# South Bruce baseline data and future growth

A number of studies and reports have been released about the changes that the DGR project may bring to South Bruce and the surrounding area. The studies start with forecasts for how the community will evolve without the proposed DGR. For example, the population of the core area (Morris-Turnberry, North Huron, Huron Kinloss, Brockton and South Bruce) is expected to grow from 33,330 to 46,390 people by 2046. That's an increase of 13,000 people.

If we look at the change in population that the proposed DGR project would bring to the core area, it's an additional 1,800 people to a total of 48,190 people. If we just look at South Bruce, this municipality is expected to grow by an additional 780 people by 2046 as a result of the project.

We should consider all options to keep our community resilient and robust. We may debate how much growth is needed to sustain rural communities, but we can all agree that some growth is necessary for our community to prosper and thrive.

We value our rural lifestyle but we also know there can be challenges. We hear about insufficient and unaffordable housing. Parents speak of their children moving away for higher education and jobs. At one time we could buy what we needed in our local town but now we may need to drive to a larger commercial centre.

The additional growth in South Bruce's population and employment from the proposed DGR is only expected to be 4% in population and 9% in employment. What is attractive about the proposed DGR project is that it would be a community-driven development, where we could decide how it is integrated into our community. The community investment from the project would give us opportunities to support programs and infrastructure to improve our municipality and our quality of life. To make South Bruce an even better version of itself.
